
THE SUFFOLK COAST

What impact will the development of Sizewell C Nuclear Power Station have on your business?

September 2021



The Suffolk Coast Destination Management Organisation (DMO) is the official tourism organisation for East Suffolk. It conducted an independent survey of tourism businesses in 2019, to understand the impact of proposed energy projects on the industry, including Sizewell C new nuclear power station (SZC) and ScottishPower Renewables' two wind farms.

The survey was repeated recently, looking exclusively at the Sizewell C project, to understand the current position on how the construction of this project could impact tourism businesses in the area and in turn, the visitor economy.


Invitations were sent to the DMOs current membership of 216 businesses, which span the Suffolk coast area from Felixstowe to Lowestoft, along with other non-member tourism businesses in the area using Survey Monkey. This was an online survey conducted between 9 and 19th September 2021. Given the short lead in time, at the end of an exhausting season following on from the disruption of the pandemic, 91 responses were received (23% response rate). 52% of respondents were operating businesses within a 10-mile radius of the proposed Sizewell C site.

Survey headlines:

- 63% of all respondents are very/fairly worried/concerned about the possible negative impact the construction of SZC will have
 on their business. This rises to 77% of respondents operating within a 10-mile radius of the project.
- 70% of all respondents think that while SZC is being constructed, visitors will be **a lot/a little less likely** to visit the Suffolk coast, 49% think they will be a lot less likely to visit. This rises to 84% of respondents operating within a 10-mile radius of the project, 64% of them think visitors will be a lot less likely to visit.
- 48% of all respondents think their annual turnover will decrease as a direct result of the development, this rises to 69% of respondents operating within a 10-mile radius of the site.
- 28% of all respondents think the project will have a negative impact on staffing levels within their business and are concerned that they will lose staff due to the project during the construction period. This rises to 45% of respondents within a 10-mile radius. 58% of all respondents don't expect staffing levels to be affected, this is 42% within a 10-mile radius.

Q1 Where is your business/workplace located in relation to Sizewell A&B?




Q2 How would you describe your level of worry/concern if any, about this period in terms of the possible negative impact on your business/organisation.









Q4 All other things being equal, what do you think the impact will be on your annual turnover during this period, as a direct result of the development?








